(Purpose: The RAN is to provide cash flow in the event of a delay in payments for state and federal programs administered by IU13. IU13's CFO will monitor the payments anticipated for July and August, and if there were a significant delay that would result in a projected cash deficit in September, the intermediate unit would initiate the borrowing outlined in the resolution. If cash flow returns to normal and all catch-up payments are received by August 31st, the RAN will not be issued, and no costs will be incurred for the RAN.)
